ORDINANCE NO. 2042

**AN ORDINANCE OF THE CITY OF BEAVER FALLS, COUNTY OF BEAVER
AND COMMONWEALTH OF PENNSYLVANIA, AMENDING ORDINANCE NO.
1838, THE RESTRICTIONS UPON OCCUPANCY OF SIDEWALKS
ORDINANCE, SECTION IV PARAGRAPH (7) CONCERNING THE
COMMERCIAL PERMITTING PROCESS FOR SIDEWALK CAFES**

BE IT ORDAINED AND ENACTED by the Council of the City of Beaver Falls, a Third Class City under the laws of the Commonwealth of Pennsylvania, and it is hereby ordained and enacted by virtue of the authority of the same as follows:

Ordinance No. 1838 is hereby amended to read as follows:

Section IV.

6. Flowers, floral arrangements, ornamental shrubbery, bedding plants, and vegetable plants may be displayed in front of the premises of any merchant where such use is permitted. Said displays shall not protrude more than two feet (2') from the building line of the merchant's premises. No floral display shall be placed as to interfere with pedestrian traffic. A minimum width of four feet (4') of continuous unobstructed sidewalk shall be available at all times for pedestrian traffic.

7. Open sidewalk cafes may be permitted in commercially zoned areas. A permit may be obtained from the City Clerk at a cost of \$25.00 following review and approval from the Beaver Falls City Council. A request for such permit may be made by the owner or tenant of a building occupied and used as a restaurant fronting the sidewalk sought to be used as an open sidewalk café. Such permit shall be valid for a period not to exceed one (1) year, and shall be renewable


after such time. The owner and/or tenant must keep the premises broom clean and free of debris at all times. Such permit is revocable by City Council at will.

10. From time to time, by Resolution, the City Council shall amend this Ordinance with respect to any additions, insertions, deletions, modifications or changes, if any, that are determined to be in the interest of the City.

Effective date. This Ordinance shall become effective immediately upon final passage.


